

Warranty and Conditions

Lumberg Inc., a Virginia corporation, ("Lumberg") warrants that its products will be free from defects in materials and workmanship for a period of twelve (12) months from date of delivery, provided (1) the products have been employed in a manner consistent with their manufacture and (2) there has been normal use in accordance with Lumberg's specifications. Should any claim of defect in material or workmanship arise during this warranty period, once a visual inspection of the product is completed by Lumberg, Lumberg, shall, in its sole discretion, either replace (not including installation charges) or repair the defective part at no charge. The above-mentioned warranty applies only to the original Buyer of the product and is subject to Buyer (i) giving prompt notice to Lumberg or its authorized distributor of the defect, (ii) establishing the normal use and service of the product and (iii) arranging the timely return (within six (6) months after the defect is discovered - shipping pre-paid) of the defective product to Lumberg or its authorized distributor. Any specifications described herein, or in any of Lumberg's written proposals, are only estimates and not intended as an express warranty. Any samples submitted to Buyer, any descriptions, illustrations, or forecasts in trade literature, brochures, or other documentation shall not be construed as warranties in any way.
